I applied to Wokingham Borough Council around 4 or 5 years ago to have some kind of pedestrian crossing put in around here. We live near St Dominics school but our children go to school at Highwood. I walked my son to school when he first started 5 years ago, but it just isn't safe to cross, cars drive too fast along here. Which has resulted in me driving my children to school now. We aren't the only ones needing to cross this road for schools, there seem to be many others. The councils response to my request was that they sent someone out to look at the area, and there wasn't enough need for a crossing. Which is nuts! They only need to look at the addresses of the families at the local schools to see that many like us feel forced to drive around a mile (which could easily be walked if it were safer!)

I've always said that that road is an accident waiting to happen, and last weekend proves it! I believe the car was upside down following its collision! What if me and my 3 young children had been trying to cross the road at this time! Or any of the elderly people who live in the sheltered accommodation on the corner of that road."

#### 127. APOLOGIES

Apologies for absence were received from Councillors Horskins and Lewis. Councillor Horskins attended the meeting virtually.

# 129. MINUTES OF THE PLANNING AND COMMUNITY COMMITTEE MEETING HELD ON 10 DECEMBER 2024

#### **RESOLVED:**

- 130. Following a proposal, Members unanimously agreed to bring forward agenda item 10 Revised Estimates 2024/25 and Budget Estimates 2025/26 for consideration as a number of applicants were in attendance to present their applications.

#### 131. REVISED ESTIMATES 2024/25 AND BUDGET ESTIMATES 2025/26

Members considered Report No. PC 1/25 and the applications received for grant funding for 2025/26.

Representatives from the Link Visiting Scheme and ReadiBus, along with the Town Council representative appointed to ARC, were in attendance and provided a short explanation of each organisations work in relation to their annual grant applications for 2025/26.

Members noted the recommendation in Report No. PC 1/25 that the Committee consider referring three annual grant applications which provide support to children and young people – ARC, First Days and Home-Start Wokingham District – to the Leisure Services Committee to be considered for the award of a Youth Grant utilising unspent 2024/25 Youth Service budget. It was highlighted this approach had been taken last year in light of the Youth Grant fund which had been setup by the Leisure Services Committee to utilise unspent 2023/24 Youth Service budget allocation. The Deputy Town Clerk confirmed that, whilst the Youth Grant fund was now spent, the 2024/25 Youth Service budget remained unspent and the Leisure Services Committee could choose to use this to fund these applications again, although this would be entirely at their discretion.

Following consideration, Members unanimously

Councillor Taylor advised Members that the Cycling & Walking task & finish working group had met on 6 January.

Members noted the issue of parking outside schools had not been raised as representatives from MyJourney Wokingham were not in attendance. Councillor Taylor advised the group had reviewed potential cycling and walking routes across Woodley, which had been collated by Councillor Jewell, and that the next steps were to walk / cycle those routes to confirm their appropriateness and identify any infrastructure improvements required, including signage. Members noted MyJourney Wokingham would then be engaged with to review the routes and compare with their own, and to discuss ways forward to progress the improvements, seeking to utilise Wokingham Borough Council funding, if available, and joint and grant funding opportunities. Before finalising, it was planned that public consultation would take place to feed into the final route maps.

Councillor Taylor advised Members that she had read Wokingham's Local Planning Enforcement Plan – July 2024 – and had noticed it referred to residents raising enforcement concerns with their local town or parish councillor who could then help to seek an informal resolution. Members were concerned by this as this was not something they were aware that residents were being advised of, and felt they would not be in a position to offer such assistance nor wished to become "piggy in the middle" between residents and the Borough Planning Enforcement team. It was requested this be raised with Wokingham Borough Council to find more information about; the Town Clerk agreed to initially raise this with other local council Clerks within Wokingham to find out if they were aware, before raising with Wokingham Borough Council officers.

#### 139.1 **Community Speedwatch**

Councillor Taylor advised Members that the Community Speedwatch Group needed to undertake more sessions, but these are weather dependent. She also advised the group needed to identify more sites, with a few currently due to be assessed.

Members noted that Wokingham Borough Council had sent out communication regarding the closure of Headley Road for the implementation of the proposed pedestrian crossing adjacent to the entrance to the Oakwood Centre. Concern was raised about the diversion route proposed, which appeared to cause issues with access to Headley Road East car park, and potential impact on the Oakwood Centre and Coronation Hall. The Town Clerk agreed to raise the matter with Wokingham Borough Council to find more information and resolve any potential issues.

These amendments are provided to protect neighbouring amenity and ensure future occupiers of the dwelling would have suitable outlook and light. Revised external materials schedule has also been provided. Lastly, the description of development has been amended to remove reference to, and alteration of, the wording of condition 5 (landscaping).

#### Observations:

The Planning & Community Committee have considered this application and object on the grounds that the Planning Inspectorate imposed condition 30 – working hours – for a reason, and that the change these would, even for a temporary period, would be unsocial and present an unreasonable level of disruption to local residents who have already been impacted by this development.

Members also noted that the applicant commented they had not undertaken any prior community engagement regarding the request for this change, and only planned to inform neighbouring residents if approved, which the committee felt was unneighbourly.

# Report of a virtual meeting of the Cycling & Walking Task & Finish Working Group held on Monday 6 January 2025 at 12.30pm

#### 1. APOLOGIES

There were no apologies for absence.

#### 2. DECLARATIONS OF INTEREST

There were no declarations of interest made by Members.

#### 3. MEETING – 7 MAY 2024

Members noted the report of the committee's meeting held on 7 May 2024, as provided in the agenda.

#### 4. ACTIVE TRAVEL ROUTE MAP PLANNING

Councillor Jewell presented suggestions for both major and connecting cycling and walking routes across Woodley, to act as a starting point for discussions. Members went through these routes and made suggestions and amendments; the map is provided at **Appendix A** for reference.

Members noted that the focus of the route mapping exercise was to provide active travel route options, not routes for leisure purposes. It was also noted that routes converge in the town centre, with an appropriate location possibly able to be used as a centralised transport hub, with provision of secure cycling storage and appropriate area maps, although it was recognised funding would need to be sought for this.

Members agreed the next steps would be for the suggested routes to be walked and / or cycled in person by Members of the committee, to be checked for their appropriateness, to identify infrastructure issues / upgrades which might be required, and to identify appropriate locations for route signage. It was suggested this should be targeted for completion by the end of March.

Once routes have been checked it was suggested the committee should meet with MyJourney Wokingham to review the routes. It was noted this would provide an opportunity to check the routes do not contradict any of MyJourney's own routes, and to discuss opportunities for MyJourney and the Town Council to work together on linking the final routes into MyJourney's schemes and map designs.

After this, Members agreed a public consultation should take place to get feedback on the suggested routes, with any comments then worked into the final maps.

It was recommended that the final maps could show some of the major bus stops in the area to help link routes into the wider transport network.

A suggestion was made that, in the long term, there was a desire to design a boundary walking route around Woodley.

#### **RESOLVED:**

◆ For Members to walk and / or cycle the suggested routes - checking their appropriateness, identifying infrastructure issues / upgrades which might be required, and identifying appropriate locations for route signage – with this work shared amongst Members; Steve Vale to check routes C & D (as indicated in Appendix A), whilst Councillors Taylor and Jewell would liaise to arrange for other routes to be covered.





#### **Wokingham Pilot Campaign**

To assess the effect a 'footpath review' may have on the Parishes in Wokingham and how these may connect to the town centre and neighbouring Authorities. Gauging opinion from local groups before presenting to Wokingham Borough Council (WBC) for their opinion.

#### The concept

A review of the footpath network to identify public footpaths that if given bridleway or restricted byway status would offer improved connections between towns, areas of settlement, places of interest e.g. schools and country parks, existing bridleways and byways. Also those that would help to offer alternatives to busy or dangerous road and to form circular routes for increased recreational opportunities. Please see the concept illustration below, no specific routes are indicated, it is appreciated that the Rivers, M4 and A329(m) increase the challenge.



#### Why

We believe recreation, Active Travel and health and well being need to go hand in hand to offer increased connectivity and safer alternatives to increasingly busy and dangerous roads for vulnerable road users. Moving Wokingham towards a greener, healthier, safer future that also addresses the inequality in the current Public Rights of way network is vital for the whole community. The current rights of way network appears to be an undervalued resource but holds enormous potential.

There are a number of current policies WBC are actively following and consulting on: The ROWIP, LCWIP, DMMO process, Greenways, SANG, Active Travel, Health and Well Being, which are all explained below. However, while each of these has excellent ideals, they don't complement each other to provide a cohesive off road network which would encourage people to choose Active travel, instead of their car, or take more exercise recreationally.

Wokingham has been chosen for this pilot for the following reasons -

• The Rights of Way Improvement plan (ROWIP) acknowledges and seeks to address the inequality in the current network, with a long list of desired routes. However, whilst it is a requirement for councils to review their ROWIP every 10 years, these are a plan for management with desired actions, but without actual Government targets to reach and actively implement.

- Active Travel options are poor, whilst the Council seeks to improve this with new Greenways (walking and cycling routes for active travel and to link the Strategic Development Locations) as part of housing development, there are challenges with this. The Local Cycling and Walking Infrastructure Plan (LCWIP) proposals for Wokingham seem to largely be on-road routes, or via shared footways which are undesirable for many reasons. Some are proposed along pavements and verges which would mean total exclusion of horse riders from roads they legally have a right to use if these are implemented Horse riders are not permitted to use on-road cycleways, it is also against the law/Highway code for a bicycle to pass a horse on their left side.
- Definitive Map Modification Order (DMMO) applications have been submitted along some footpaths in the Borough on historic evidence, some also with user evidence.
- The Borough is urban/rural, each parish is different.
- The Public Rights of Way (PRoW) network is extensive but only approximately 10% is bridleway, less than half the national average of 22% which in itself is considered woefully inadequate.
- The bridleway network is fragmented, leaving vulnerable users unable to avoid increasingly busy roads. There is only one very short bridleway circuit in Barkham, all other circular routes in the Borough are footpath so only available to pedestrians.
- Off road access between bridleways, byways, areas of settlement, towns, villages, schools and places of
  interest e.g. country parks, is limited. The proposed Greenways will assist with this, but gaps will still
  remain. For horse riders, access to the Greenways in Wokingham will only be where possible some
  Greenways will cross SANG (Suitable Alternative Natural Greenspace) areas or follow footways where only
  pedestrian use is currently permitted.
- Parts of the footpath network are inaccessible to those who have a right to use it for kissing gates, steps, stiles and other barriers. Only able bodied people can negotiate these, excluding access by disabled, elderly and parents with buggies and prams.
- Health and Well being, including mental health are vital, the 2020 pandemic proved how vital access to the outdoors is for everyone. Also with an 'ageing population', staying active is really important.
- Wokingham has a high percentage of horse owners living in the Borough. Recreational horse riding is essential for the survival of equestrianism, an improved PRoW network could help to secure its future.

#### How

I see this as potentially an easy win for the Council. The infrastructure largely already exists, but too much of it is only open to pedestrians.

- Not all footpaths would be needed. Surely this suggestion is preferable to 'The Right to Roam'? Providing a useful compromise as part of the much needed public gain.
- Footpaths would be chosen for upgrade for their location and convenient links they could offer, coupled with the minimum width of 3m. Trimming may be required in some places to achieve width/height where this exists but overgrowth has restricted the available space. Pinch points (e.g. tree jutting into the way) should not be an issue if there is space to pass either side of it. Some landowners may be willing to support the community need by widening narrower paths in situations where the path is highly desirable but currently too narrow. With an agreement for allowing higher rights, there should also be scope to move paths to a more desirable location, either to form more direct routes or that suit the land owner better than the current path e.g. moving the route to a boundary.
- There may be a cost implication where surface/drainage improvements are needed. However, as these footpaths are already in use by the public, if they are already in a poor state, any improvements needed, would surely be needed anyway to allow continued/improved access by those other than pedestrians who already have the right to use them e.g. wheelchair users. Funding may be gained from existing grants, also by fund raising from groups who will benefit from the upgraded/reclassified routes.
- DMMO application routes applied for as bridleway, or restricted Byway, that already have footpath classification and would help to provide the above benefits, could be given their higher status more quickly, saving the Council money. This money could instead be spent on pathway improvements. It is appreciated that Government policy for a fast track system would probably be needed to make this possible.
- To identify which footpaths to reclassify, stakeholders representing the user groups should be consulted and public consultations held. ROWIP, Active Travel and LCWIP plans considered to bring together one plan with timescales for phased delivery. Potential target of 2050 to reach completion.

#### **Benefits**

**Walkers** - No reduction in access, walkers would be able to continue using 100% of the off road network. Walkers would still retain sole use of the majority of the network and would benefit from any drainage and surface improvements made. As they age and their mobility is reduced, they would have easier access to the improved routes, with increased width and without barriers that may otherwise prevent them from continuing to enjoy walking. Knowledge that by sharing more routes with other users they are assisting with provision of a community need.

**Cyclists** - Increase in available off road routes, for both Active Travel and recreation. Opportunity to avoid riding on the roads and feel safer without the motorised traffic. Ability to enjoy more of the countryside. Increased opportunities to also ride with others who are currently put off riding their bike for fear of accidents on the road. Parents may be more encouraged to ride with their children and feel more confident allowing their children (of an appropriate age) to ride with their friends unsupervised and cycle to school. Cycling is currently a male dominated activity, increasing off road access may encourage more women to take up cycling.

Horse riders - Increase in available off road routes, for both Active Travel and recreation. Opportunity to avoid riding on the roads and feel safer without the motorised traffic. Ability to enjoy more of the countryside. Increased opportunities to also ride with others who are currently put off riding their horse out towards their nearest bridleway for fear of accidents on the road. Parents may feel more confident allowing their children (of an appropriate age to ride out with their friends unsupervised. Horse riding is a female dominated activity, there are policies to encourage women to take up and remain in sport, increasing recreational horse riding activities will support these.

**Disabled and Elderly** - Increase in available routes that are easier to navigate, for both Active Travel and recreation. Opportunity to enjoy more of the countryside instead of having to use the roads with mobility aids such as 'trampers', or walking on pavements next to motorised traffic. We are an ageing population, staying active is vital to assist in maintaining health and well being. Wider routes with improved surfaces will allow easier access by wheelchair, including those who need their legs elevated. Also, easier use by those who need someone to walk by their side e.g. partially sighted or those with conditions that affect their balance, such as Parkinson's.

Parents with buggies and prams, children on wheeled toys such as scooters, balance bikes etc - Increase in available routes for both Active Travel and recreation. Opportunity to enjoy more of the countryside, giving children a little more freedom to safely use their wheeled toys or toddle on foot without the worry of motorised traffic next to them. Safer and easier to control children on off road pathways than along road edge pavements when they could fall off their wheeled toy into the road. Increased width and improved surfaces that will allow buggies and prams to pass through barriers and past other users more easily.

**Landowners** - Opportunity to move pathways that are through fields to boundaries that suit them better, or give more space between a public route and their home. Knowledge that by agreeing to higher rights on a footpath they own, they are supporting the whole community, increasing safety and enjoyment of the countryside. Allowing these routes to remain in perpetuity for many future generations to also enjoy.

#### **Objective and desired outcome**

Gaining improved connectivity between existing bridleways and byways, also towns, villages and places of interest (e.g. country parks, schools etc). Creation of circular routes, please see concept illustration above. Ultimate goal of a circular, off road, bridleway route in every parish which are linked, forming a 'honeycomb' or spiders web pattern of bridleways and byways over the whole of the Wokingham Borough.

A high level of support for the concept from all local groups with an interest in access that represent the Borough and Wokingham community as a whole.

Wokingham Borough Council to voice their support for the pilot. An agreement in principle, they have the power or should there be a Govt. policy for a 'footpath review', that they would be willing to adopt this and actively implement the necessary revisions to the existing network.

# **Woodley to Reading Active Travel Route Summary of Design Changes**

Woodlands Avenue East (Woodley town centre to Howth Drive)

- A 2.3m cycle track is proposed along the northern side of Woodlands Avenue taking space from existing verges. The carriageway would be retained as a two-way 5.5m wide in response to your concerns over the previously proposed narrowing to 5m.
  - The verges and existing footway on the south side would be largely kept, except for a narrow section of verge between Woodwaye and Howth Drive.
- 2 An uncontrolled crossing would be provided on raised table following stakeholders' requests.
- Proposals for "continuous footways" crossings at side road junctions which encourage drivers to give way to pedestrians would be kept, following your overall agreement to this change (60% of the consultation respondents agreed with this intervention).
- The mini-roundabout on Howth Drive would become a T-junction with cycle track crossing. The lay-by parking opposite would be reduced to one vehicle space to facilitate any turning movements at the new junction layout while improving drainage in a more sustainable way. Replacement spaces are no longer considered at Port Close to minimise maintenance costs.
- Subject to Reading Borough Council agreeing, we aim to plant on green space next to Howth Drive to make up for the loss of trees following your overall support to this proposal (76% of the consultation respondents agreed with the proposal to include new areas of planting and greenery).










# Woodley to Reading Active Travel Route Summary of Design Changes

**Woodlands Avenue West (Howth Drive to Church Road)** 

- Existing shared use path would be retained and if possible widened to 4m. This is based on your feedback that the present shared use provision is sufficient, whilst it was also proposed during a value engineering workshop with Active Travel England to reduce scheme cost and enable us to deliver the entire route.
- The Addington school entrance would be retained with priority provided to pedestrians and cyclists over the vehicular traffic.
- Zebra crossings along Woodlands Avenue West would be provided on shallow raised tables to improve safety for pedestrians and cyclists and reinforce the proposed 20mph speed limit. 68% of the consultation respondents agreed with the proposal to create new and improved crossing points, while more crossing points was one of the ways you mentioned that it would help you to cycle or walk more in this area.
- g Existing lay-bys have been retained following stakeholders' concerns about the removal of parking spaces.









# Woodley to Reading Active Travel Route Summary of Design Changes

**Church Road, Palmerstone Road and Culver Lane** 

- The proposed cycle track stops at the Palmerstone Road junction and a continuous footway crossing at this location has been adjusted to tie into the existing layout.
- The speed limit on Palmerstone Road and Culver Lane would also be reduced to 20mph following your overall agreement to this proposed element, while all side road junctions on the south side of Culver Lane would be improved to give cyclists and pedestrians priority. 55% of the consultation respondents agreed with the proposal to reduce the speed limit along Woodlands Avenue, Palmerstone Road and Culver lane limit to 20mph.
- Double yellow lines would be painted to restrict parking along Culver Lane.
- Existing parking bays west of Culver Lane would be retained whilst a short section of shared use route is now proposed following stakeholders' requests. Due to the narrow road under the bridge a give way system to oncoming traffic has been proposed.
