## **Terms and Conditions**

- Children's Party bookings can only be considered confirmed once a booking form has been completed and signed and after full payment has been made.
- The hirer may enter the party tea room fifteen minutes before the time stated on the booking form to set up any food and decorations.
- If the hirer has arranged for one of our approved providers to organise their party activities for them, we will provide up to thirty minutes either side of the booked sports hall or 3G Pitch time if needed to allow the set up and set down of any equipment required.
- The hosting / hiring parent remains responsible for the supervision and safety of all children attending the party.
- Where unreasonable damage is caused to equipment (including any chairs, tables, hired party equipment etc) by the hirer or their guests, by signing these terms and conditions the hirer accepts responsibility for paying any necessary repair or replacement fees.
- A minimum of three weeks' notice is required from the hirer to cancel or transfer a booking. All refunds are at the discretion of the Centre Manager and if approved will also incur a 20% administration charge.
- We reserve the right to amend, cancel or reschedule any booking that has been confirmed when caused by events beyond our reasonable control.
- Throughout the duration of the booking Woodley Town Council is under no liability in respect of personal injury, harm, loss or damage, however caused, except by proven negligence on the part of the Council or its employees.

## **Bouncy Castle / Inflatable Equipment Hire Agreement**

It is the responsibility of the named parent / hirer to ensure that all of the following rules and regulations relating to the use and hire or our inflatable equipment are followed at all times:

- A responsible adult (+17 years) must supervise the inflatable equipment at all times.
- The supervising adult must ensure that all children using the inflatable are not fighting, pushing, colliding or behaving in a manner likely to cause harm or distress to others.
- The supervising adult must ensure that nobody with back or neck problems or any other medical condition that could be reasonably aggravated uses the inflatable equipment.
- The supervising adult must ensure that no more than sixteen children are using the inflatable equipment at the same time and that nobody over the age of nine years old uses the inflatable equipment.
- The supervising adult must ensure that children do not go around the back of the inflatable.
- The supervising adult must ensure that socks are worn at all times (but no shoes), that glasses and jewellery are removed and that any sharp objects are removed from pockets.
- The supervising adult must ensure that participants do not attempt summersaults or flips.
